SPONSOR'S POLICY:

All cancellations must be in writing. There is a deduction of 25% of registration fee for cancellations before November 1st, 2017. No cancellations will be accepted or refunds given after November 1st, 2017. There is a 100% no refund policy applied. All fees related to bounced checks and/or charge backs will be the responsibility of the registrant.

VENDOR'S POLICY:

REGISTRATION/PAYMENT: Registrants for this event hereby agree to abide by these policies as outlined herein. The vendor's registration rate is \$100, includes one vendor's pass, one table and one chair. There are two table sizes to choose from. This is based on first come first serve basis. Tables classifications are: one round table that seats 10 individuals and one rectangular table that is approximately 2 feet wide and 6 feet long. Only complete registrations and payment will be assigned vendor's space. Registration and payment will be accepted online, by phone, fax or mail. Table sharing is allowed. In this case the second person at the table has to pay an additional \$10 fee in advance or \$15 at the door.

CANCELLATIONS: All cancellations must be in writing. There is a deduction of 25% of registration fee for cancellations before November 1st, 2017. No cancellations will be accepted or refunds given after November 1st, 2017- the 100% no refund policy is applied. Anyone registering as a vendor after November 1st, 2017 will not be refunded and cancellation will be denied. All fees related to bounced checks and/or charge backs will be the responsibility of the registrant.
